REGULAR MEETING MINUTES

CALL TO ORDER

The Regular Meeting of the Milford Borough Common Council was held at Milford Firehouse located at 21 Water Street on September 3, 2024. The meeting was called to order by Henry Schepens, Mayor at 7:00PM.

<u>PLEDGE OF ALLEGIANCE</u> was led by Mayor Schepens.

SUNSHINE PROCLAMATION was read by Mayor Schepens.

As required by the Open Public Meetings Act of 1975, adequate notice of this meeting was provided on January 11, 2024 in the Hunterdon County Democrat and Express Times newspapers. Notices were also posted on the bulletin boards both inside and outside the Municipal Building and at the Milford Public Library.

ROLL CALL

NEW BUSINESS

<u>Hunterdon County Commissioners awarded \$40,000 to the Borough to move to the Library</u> Mayor Schepens announced the County has awarded the Borough with a \$40,000 grant for expenses associated with the move to the Library.

UNFINISHED BUSINESS

Elizabethtown Gas Project Update

The Borough will be appointing a special project engineer to oversee the installation of natural gas infrastructure as sought by Milford residents. Due to the multitude of current projects being administered by the Borough Engineer, the special engineer will only be responsible for the natural gas installation. The Council discussed marking out the existing utilities and other procedural processes.

LEGAL AFFAIRS REPORT - TODD BOLIG, ESQ.

- Attorney Bolig stated RE2024-086 pertains to the appointment of a special project engineer for the installation of natural gas.
- Attorney Bolig reported that he has been contacted by a new developer for Pleasant View Estates. They are proposing to change the name of the development to River Ridge Farm Estates. The developer's agreement will need to be revised due to the increase in costs since the prior agreement. In addition, the attorney will review the original approvals granted by the Planning Board for compliance with the approval timelines established in the MLUL.
- Attorney Bolig reported that the official tax maps need to be revised for accuracy. The state requires this information to be updated in order for the revaluation to occur.

<u>REPORTS FROM DEPARTMENT COMMISSIONERS</u> <u>ADMINISTRATION/SAFETY – MAYOR HENRY SCHEPENS</u>

- Mayor Schepens reported on a bipartisan bill which proposes an amendment to increase the amount of veterans' property tax deductions from \$250 to \$2,500 over four years.
- Mayor Schepens reported he received a letter written to the NJDEP stating that the Municipalities are not in favor of all the Stormwater Tier A requirements. The letter states that the requirements are unsustainable.
- Mayor Schepens reported that he had a meeting with Councilman Sloyer and the water department to discuss the need for additional resources. The Mayor commented on selling the water department in the future under the Water Infrastructure Protection Act or by referendum.

In the absence of Councilwoman LaFevre, Councilwoman Yager gave the Liaison report in place of Buildings & Grounds.

LIAISON – COUNCILWOMAN YAGER

- Councilwoman Yager reported that she attended the Board of Education meeting. The school year started on August 27th with a full staff. She commented on the number of children attending the school, state testing, and maintenance upgrades.
- Councilwoman Yager reported that the Milford Merchant's Association decided that Milford Alive would become a biannual event. The next event after this year will be in 2026. The Association needs additional volunteers and members to help plan and coordinate the event.
- Councilwoman Yager reported from the Historical Society that the Milford School students raised over \$600 in Penny Wars, and a total around \$900 to put towards a headstone for Dr. George Ribble. He was a civil war veteran as well as a doctor in Town. The application for the headstone was denied by the Veteran's Administration, because there was not adequate proof that he was buried at the Milford/Union Cemetery. Councilwoman LaFevre is looking for additional documentation.

SOLID WASTE/RECYCLING – COUNCILMAN GALLOS

Councilman Gallos stated there hasn't been any complaints received. Mayor Schepens reported 110 Dawn Road has not been taking the garbage out for pickup. He requested that the zoning officer send a letter to the owner.

ORDINANCE – FIRST READING

ORDINANCE NUMBER 988-2024 AN ORDINANCE OF THE BOROUGH OF MILFORD, COUNTY OF HUNTERDON, STATE OFNEW JERSEY, REGULATING DETACHED ACCESSORY BUILDINGS WITHIN THE BOROUGH

WHEREAS, the Borough of Milford finds it desirable and in the best interest of the Borough to permit detached accessory buildings and structures to be located in areas other than to the rear of the rear building line of principal structures, under limited circumstances, for the betterment of the Borough; and

WHEREAS, the Borough's purpose underlying this Section is to enable Borough

residents to make use of detached accessory buildings and structures, under limited circumstances, if it is not possible for the same to be located in the rear of the rear building line of principal structures; and

WHEREAS, the Borough of Milford finds it desirable and in the best interest of the Borough to amend the Detached Accessory Buildings ordinance at §190-7E.; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Common Council of the Borough of Milford, County of Hunterdon, and State of New Jersey, the Detached Accessory Buildings ordinance at §190-7E. is amended as follows:

E. Detached accessory buildings or structures. Detached accessory buildings or structures shall be located to the rear of the rear building line of principal structure and shall comply with the provisions of this chapter governing their location. If it is not possible to locate a detached accessory building or structure to the rear of the rear building line of the principal structure due to either the size of the rear area or slope of the ground, then the detached accessory building or structure may be located in the side yard to the rear of the front building line of the principal structure but in no circumstances shall be located in the front yard, and shall comply with the provisions of this chapter governing their location.

This ordinance will be further considered for final passage by the said Common Council at the Milford Fire Company Building, 21 Water Street, Milford, NJ at a meeting beginning at 7:00pm to be held on October 7, 2024 or at any time and place to which such meeting may be adjourned. RESOLUTION NO. RE2024-080 GOVERNING BODY CERTIFICATION OF THE ANNUAL AUDIT

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

RESOLUTION OF THE BOROUGH OF MILFORD APPOINTING WAYNE INGRAM, PE, PLS, PP, CME, OF FRENCH & PARELLO ASSOCIATES, TO SERVE AS "SPECIAL PROJECT / CONSULTING ENGINEER" FOR ENGINEERING OVERSIGHT RELATING TO ELIZABETHTOWN GAS COMPANY'S INSTALLATION OF NATURAL GAS INFRASTRUCTURE WITHIN THE BOROUGH OF MILFORD WITH ALL FEES FOR SAME TO BE PAID EXCLUSIVELY THROUGH ESCROWED

FUNDS.

WHEREAS, the Milford Borough Common Council recognizes a need to acquire professional engineering services pursuant to the provisions of <u>N.J.S.A.</u> 19:44A-20.5 and -24, as appropriate; and

WHEREAS, the Milford Borough Common Council recognizes that a temporary "Special Project / Consulting Engineer" is both desireable and necessary to oversee the installation of natural gas infrastructure as sought by Milford residents within the Borough of Milford as to be performed by Elizabethtown Gas Company ("ETG") and (the "Project"); and

WHEREAS, the Council recognizes this need in light of the multitude of additional projects and demands currently placed upon the Borough's Municipal Engineer, which include but are not limited to: the on-going move of Borough Hall to the Milford Public Library; the official close-out of all the NJDEP and EPA projects; the restoration of Quecommissicong Creek's embankment and the attendant permits and approvals required for same; and the Statemandated digitizing of the Borough's official tax maps as is required prior to the Borough commencing the 2025 Borough-wide tax revaluation; and

WHEREAS, the Council wishes to appoint Engineer Wayne Ingram, PE, PLS, PP, CME, of French Parello Associates effective immediately and until the conclusion of ETG's installation of gas mains within the Borough; and

WHEREAS, Engineer Ingram is fully licensed within the State of New Jersey in a variety of engineering and surveying capacities and has extensive experience with respect to the installation of natural gas-related infrastructure. He is also experienced with the operations of both Elizabethtown Gas Company and its contractors.

WHEREAS, Engineer Ingram's and his firm's hourly rates for services for the Project are attached hereto and made a part hereof; and

WHEREAS, the fees for said engineering services will be paid separately from the Milford Borough Budget and are to be paid through an escrow account that will be solely funded by Elizabethtown Gas Company as pertains to the Project; and

WHEREAS, a Certification of Availability of Funds is not necessary since the fees for the engineering services related to the Project, as to be provided by Engineer Ingram, will be paid exclusively by Elizabethtown Gas Company; and

WHEREAS, the Local Public Contracts, Law, <u>N.J.S.A.</u> 40A:11-1, *et seq.*, requires a resolution authorizing the award of contracts for "Professional Services" without competitive bids and that the contract itself be available for public inspection as set forth herein; and

WHEREAS, Wayne Ingram, PE, PLS, PP, CME, shall complete and timely submit all required documentation including but not limited to a "Mandatory Equal Employement Opportunity Language Statement, <u>N.J.S.A.</u> 10:5-31, et seq.; current Certificate of Employee Information Report; Non-Collusion Affidavit; Business Ownership Disclosure; and Political Contribution Disclosure, etc, which certifies that neither he nor the firm of French Parello Associates have made any reportable contributions to a political or candidate committee in the previous one year, and that the contract shall prohibit Mr. Ingram and French Parello Associates from making any reportable contributions throughout the term of the contract.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of Milford Borough, County of Hunterdon, State of New Jersey, as follows:

1. That all aforementioned recitals are incorporated herein as though fully set forth at length; and

2. Mr. Wayne Ingram, PP, PLS, PP, CME, of French Parillo Associates is hereby immediately appointed as the Borough's "Special Project / Consulting Engineer" for the engineering oversight of the installation of natural gas infrastructure as sought by Milford residents within the Borough of Milford and as to be performed by Elizabethtown Gas Company (the "Project"); and

3. That all of Engineer Ingram's fees for services rendered shall be paid separately from the Milford Borough budget and received solely from ETG who has / shall establish an escrow account which is to be funded solely by ETG; and

4. Engineer Ingram shall provide to the Borough all required documentation including but not limited to a "Mandatory Equal Employement Opportunity Language Statement, <u>N.J.S.A.</u> 10:5-31, *et seq.*; current Certificate of Employee Information Report; Non-Collusion Affidavit; Business Ownership Disclosure; and Political Contribution Disclosure, and any other New Jersey Pay-to-Play forms, and a copy of French Parillo Associates' Certificate of Insurance naming the Borough as additional insured; and

5. That the Mayor of the Borough of Milford is hereby authorized to enter into said contract with Mr. Ingram of French Parello Associates; and

6. That notice of this action shall be published as required by law within ten (10) days of its passage.
